Subject: Summary of WRAP Board conference call of July 19, 2013

The WRAP Board of Directors met by conference call on Friday July 19th from 100 to 145 PM Mountain Daylight Time. Eleven (11) of the 16 active Board members or designated substitutes attended the call, as shown in the following table, along with WRAP and WESTAR Council staff. The Board had a quorum present for the call, in compliance with the WRAP Charter, but no votes were taken. The purpose of the call was to discuss the formation of a subcommittee of the Board to review and propose any needed revisions to the current WRAP Charter (http://www.wrapair2.org/Revised_WRAP_Charter_approved_December_2009.pdf). The work of the subcommittee will occur during the next few weeks, so the process for the administrative transition of the WRAP organization from the Western Governors' Association to the WESTAR Council can be accomplished by October 1, 2013. Volunteers were requested from among the Board members; the Board Subcommittee members are: Sandra Silva, USFWS, Ursula Kramer, Pima County DEQ, Julie Simpson, Nez Perce Tribe, and Alice Edwards, Alaska DEC. EPA R9 (Colleen McKaughan and Tom Webb) and Dan Johnson of WESTAR will track the Subcommittee's work with respect to the EPA Regional Haze grant being transferred to WESTAR, and on behalf of WESTAR Council, respectively. The Subcommittee will prepare a package of any proposed changes for the entire Board's review and consideration on an August 23rd Board call; the proposed changes and call-in information will be posted on the WRAP calendar by mid-August. The Board plans to then submit a proposal for a revised Charter to a vote of the membership by September 1st. All WRAP members are welcome and encouraged to participate in Board calls and meetings.

In addition, a review of the status of WRAP projects was discussed, including the projects and grant monies that will transfer to WESTAR as part of the move of the WRAP, also by October 1, 2013.

The next WRAP Board call will be Friday August 23, 2013 at 100 PM Mountain Daylight Time.
